

### IMPACTS OF THE MANUFACTURING GROWTH PROGRAMME ON SME MANUFACTURERS



38.9%

38.9% of manufacturers surveyed stated 'increasing productivity' was the biggest impact on their manufacturing business after gaining support from the Manufacturing Growth Programme.





### ONCE THE MANUFACTURING GROWTH PROGRAMME ENDS, WHERE WILL YOU GO FOR SUPPORT?

91.23%

91.23% of SME manufacturers surveyed stated they <u>did not</u> know where to go for manufacturing business support once the Manufacturing Growth Programme ends in 2023.



Reading the comments from these inspiring manufacturing business leaders; it reaffirms the success of the programme, which, on paper has achieved enviable results.

Furthermore, it is worrying to read that 91.23% of our SME manufacturing clients are unaware of alternative manufacturing business support considering the end of the Manufacturing Growth Programme is merely months away.

It is visible from the figures in the report that local economy needs targeted manufacturing support to continue to help SMEs increase their productivity.

We would strongly urge local policy makers to look at their future plans - and invest in SME manufacturing growth.

There is a clear need for bespoke SME manufacturing investment. After all, a figure of 7,600 completed MGP business improvement projects can't be wrong.
